DeMOLAY HONOR NOMINATION

(For Legion of Honor (*Active*), Honorary Legion of Honor
Cross of Honor *and* Chevalier)

Nomination Fee. The nomination fees as established by the International Supreme Council must be attached to this form when it is submitted. Make checks payable to *International Supreme Council, Order of DeMolay*.

Legion of Honor(*Active*). The Supreme Council may confer the DeMolay Legion of Honor upon a Senior DeMolay, who is over twenty-five (25) years of age before January 15, for outstanding leadership in some field of endeavor, or for success in fraternal life, including adult service to the Order of DeMolay.

Honorary Legion of Honor. The Supreme Council may confer the DeMolay Honorary Legion of Honor upon a Mason who is not a Senior DeMolay, who is thirty (30) years of age before January 15, and who has performed unusual and meritorious service in behalf of the Order of DeMolay, or who has evidenced a spirit of cooperation and appreciation for the Order of DeMolay. It shall not be given *only* for service on Advisory Council.

Cross of Honor. The Supreme Council may confer the DeMolay Cross of Honor upon a present or past member of an Advisory Council or upon any personal representative of an Executive Officer who has served at least three years in either or both capacities and who has been a Master Mason or Senior DeMolay in good standing during that period, and whose service has been conspicuously meritorious.

Chevalier. The Supreme Council may confer the Degree of Chevalier upon a member of the Order of DeMolay or a Senior DeMolay who has performed unusual and meritorious service in behalf of the Order, who has attained the age of seventeen (17) years as of January 15 of the year nominated and has been a member in good standing for a period of not less than two (2) years on January 15.

Nominations. Nominations for any of the four above named honors must be made to the Supreme Council by an Executive Officer. Recommendation for any of these honors may be made by an Advisory Council of a Chapter to the Executive Officer of the Supreme Council for a Jurisdiction, who *may* nominate, if he desires, to the Supreme Council, such nominees as he deems worthy.

Nomination Form. Please complete this form so that all information is clear and legible.

Regalia. In the case of the L.O.H., H.L.O.H. and Chevalier, the ritual requires the presentation of the appropriate Cordon, Medallion and Patent of Membership. The C.O.H. requires the presentation of the Breast Jewel and Patent of Membership. The regalia in all cases is sent to the Executive Officer of a Jurisdiction, or to his appointed representative.

Ring Optional. In the case of the L.O.H., H.L.O.H. and Chevalier, a ring is available on an optional basis, and information on the ring will be included when the nominee is notified of his election.

Investiture. The investiture for the L.O.H., H.L.O.H. and conferral of the C.O.H. is under the direction of the Executive Officer of the Supreme Council for each Jurisdiction. The Executive Officer will notify the Honor men-elect when and where the investiture will be made. The investiture for Chevalier is under the direction of the Executive Officer, or each Chapter Advisory Council, as the Executive Officer may direct.

Deadlines. The nomination form must reach the Executive Officer in your Jurisdiction by the Jurisdiction's established deadline. This nomination form must reach the office of the Grand Secretary by April 1.
